Membership begins upon acceptance of this application by the **WMAO** and lasts until the end of the current calendar year. At the end of this period, membership is extended by 12 months. Termination by the member must be in writing and must be made with three months' notice to the end of the calendar year.

Membership fees are generally calculated and invoiced in advance for the current calendar year. The invoice will be sent by e-mail and must be paid within the specified period. If the membership fee is more than 4 weeks in arrears, a new invoice will be issued plus a reminder fee of €12. The arrears including the reminder fee must then be settled within 2 weeks. If this is not done again, the conditions of the regular dunning procedure will apply.

The annual contribution to the **WMAO** is €18 for minors and €36 from the age of 18.

For members, participation in general **WMAO** courses or seminars is cheaper than for non-members.

Officers in third-party organizations who apply for membership of the **WMAO** declare with their application that no intentional damage to the **WMAO**, its processes or its members is intended. Corresponding memberships and functions are disclosed below. The individual examination for acceptance of the application for membership is subject to correct information being provided in this section of the application. False statements will result in exclusion from the WMAO, and any damage caused will be prosecuted.

Gross violations of this will be punished with immediate expulsion from the **WMAO**. During the training sessions, the instructions of the training instructor must be followed at all times in order to avoid endangering oneself and/or other participants.

We expressly point out that the **WMAO** accepts no liability for the loss or theft of property and/or valuables. Liability for damage to health caused by practicing the respective martial arts discipline is also excluded. Participation in events, courses, seminars and training is therefore always at the participant's own risk. Damages due to gross negligence or willful misconduct are not excluded.

In the interests of preventive health care, we expressly recommend a comprehensive sports medical examination. With this application for membership, the new member (in the case of minors, their legal guardian) agrees to the aforementioned regulations.

The personal data transmitted will be stored and processed on a computer system for the purpose of administration within the scope of the **WMAO** activities. Forwarding to third parties takes place exclusively in relation to member administration for the creation of a digital ID card, for listing for examinations and licenses, as well as for the dispatch of material to the commissioned deliverers. The use of the digital ID card is linked to an app and is currently only available to adult members after their confirmation and independent use of the corresponding app.
